## APPROVING ADDENDUM TO AGREEMENT BETWEEN THE CITY OF DES MOINES AND THE INGERSOLL GRAND SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT AND AMENDING THE BUDGET FOR THE INGERSOLL-GRAND SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT

WHEREAS, on December 21, 2015, the city of Des Moines Iowa entered into an agreement (the "Operating Agreement") with the Ingersoll Grand Self-Supported Municipal Improvement District, an Iowa not-for profit corporation (the "Operator"); and,

WHEREAS, the Operator desires to facilitate work on the Ingersoll Streetscapes project; and,

WHEREAS, the City is willing to provide financial support for the Operator to obtain certain engineering and architectural services; and,

WHEREAS, the Operator and the City have negotiated an addendum to the Operating Agreement to allow Operator to obtain planning and design services and provide for payments from the Ingersoll Grand Self-Supported Municipal Improvement District (the "SSMID"); and,

WHEREAS, the Agreement provides for procurement of engineering and architectural services that the City Engineer recommends be exempt from the provisions of Des Moines Municipal Code section 2-746 regarding procurement of goods and services because the engineering and design services will be provided by the firm that has already provided the same services for the Ingersoll Streetscapes project in the past.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council finds that the use of funds to design the Ingersoll Streetscapes Project furthers the objectives of the Urban Renewal Plan to provide a safe, attractive environment for residents with complementary uses and services that enhance the residential development and provide employment opportunities for local residents in the Ingersoll Grand Commercial Area and create an environment which will protect the health, safety and general welfare of City residents.

2. The budget approved for the SSMID is hereby amended to conform to the Agreement.

3. The City Council, exempts this negotiated contract for professional engineering and architectural services from the engineering department's RFP process and the advertising requirement of Des Moines Code pursuant to Des Moines Municipal Code section 2-746 (b)(2)
