PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON BIRDLAND MARINA UTILITY IMPROVEMENTS; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS MINTURN, INC., CLINTON M. RHOADS, PRESIDENT, \$132,890.00

WHEREAS, on March 6, 2017, under Roll Call No. 17-0344, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Birdland Marina Utility Improvements, 11-2017-008

The improvement includes installation of sanitary sewer service, water service, subdrain, drainage structures, and fire hydrant, along with Hot Mix Asphalt (HMA) and Portland Cement Concrete (PCC) pavement patching, PCC sidewalk, pavement removal, pavement markings, erosion control, site restoration, and other associated work and incidental items; in accordance with the contract documents, including Plan File Nos. 579-055/067, at Birdland Park and Marina, along Saylor Road from Birdland Marina to Guthrie Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
