Chapman, General Manager, 2401 SE Tones Drive, Ste. 13, Ankeny, IA, 50021 dated April 17, 2017, for the construction of the following improvement:

Glendale Cemetery Road Reconstruction, 11-2017-005

The improvement includes reconstruction of Glendale Cemetery roads including pavement removal, manhole adjustments, subgrade treatment, Portland Concrete Cement (PCC) curb and gutter, and Hot Mix Asphalt (HMA) paving; all in accordance with the contract documents including Plan File Nos. 579-042/054 at Glendale Cemetery, 4909 University Avenue, Des Moines, Iowa

BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments, and the City Clerk, be and is hereby authorized and directed to attest to same. No contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

BE IT FURTHER RESOLVED: That after said contract has been executed by the Mayor, the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.

BE IT FURTHER RESOLVED: That the attached Permission to Sublet form, from said Contractor requesting permission to sublet designated items, be and is hereby approved, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments; and each subcontractor is hereby granted permission to work on said improvement.
