## RESOLUTION AUTHORIZING AND APPROVING PARTIAL ABANDONMENT AND RELEASE OF PUBLIC UTILITY EASEMENT IN PROPERTY LOCATED NORTH OF DES MOINES STREET BETWEEN EAST $2^{\rm ND}$ STREET AND EAST $4^{\rm TH}$ STREET

WHEREAS, as part of the redevelopment project known as the Bridge District, there is no longer a public need for the public utility easement interests described herein and the public would not be inconvenienced by reason of the partial abandonment and release of said Easement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. There is no public need for the public utility easement interests described herein and the public would not be inconvenienced by reason of the partial abandonment and release of the Easement in the property specifically described as follows:

ALL THAT PART OF THAT 10.00 FEET WIDE PUBLIC UTILITY EASEMENT CENTERED ON THE COMMON LINES BETWEEN LOTS 9 AND 15, LOTS 10 AND 14, AND LOTS 11 AND 13 IN RIVER RILLS PLAT SEVEN, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, LYING WITHIN THE FOLLOWING DESCRIBED PROPERTY:

LOTS 9, 10, 11, AND 13; AND THAT PART OF LOT 14 DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 14, THENCE SOUTH 74°49′44″ WEST ALONG THE NORTHERLY LINE OF SAID LOT 14, 211.08 FEET TO THE NORTHWEST CORNER THEREOF; THENCE SOUTH 05°53′17″ EAST ALONG THE WESTERLY LINE OF SAID LOT 14 A DISTANCE OF 134.05 FEET; THENCE NORTH 74°29′02″ EAST 216.31 FEET TO A POINT ON THE EASTERLY LINE OF SAID LOT 14; THENCE ALONG THE EASTERLY LINE OF SAID LOT 14, SAID LINE BEING A CURVE WHICH IS CONCAVE WESTERLY HAVING A CENTRAL ANGLE OF 04°27′12″ AND A CHORD BEARING NORTH 08°44′03″ WEST, AN ARC DISTANCE OF 90.55 FEET; THENCE CONTINUING ALONG THE EASTERLY LINE OF SAID LOT 14 NORTH 06°30′27″ WEST A DISTANCE OF 41.50 FEET TO THE POINT OF BEGINNING; ALL IN RIVER HILLS PLAT SEVEN, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.
