## CONDITIONALLY APPROVING FINAL SUBDIVISION PLAT SAYLOR FIRE STATION PLAT 1

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on October 7, 2015; and,



2. The subdivision plat entitled Saylor Fire Station Plat 1 is hereby approved subject to approval of legal documents by Polk County, Iowa and review by the City Legal Department.

3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat, if necessary and as appropriate. The City Clerk is further directed to provide, if so advised by the City Legal Department, the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Community Development Department for delivery to the County Auditor for recording by the plat proprietors.
