RESOLUTION SCHEDULING HEARING ON PROPOSED AMENDMENTS TO THE ZONING ORDINANCE REGARDING SALE OF CONSUMER FIREWORKS

WHEREAS, the City Plan and Zoning Commission will hold a public hearing held on June 1, 2017, to provide a recommendation to City Council regarding the proposed adoption of Section 134-1281 and amendments to Sections 134-1087, 134-1122 and 134-1267 of the Zoning Ordinance of the Des Moines Municipal Code to allow the sale of consumer fireworks as a principal permitted use, and not as a permitted accessory use, only in industrial zoning districts ("M-1" Light Industrial District and "M-2" Heavy Industrial District) and outside of the Downtown Overlay District, in accordance with recently adopted Iowa legislation; and

WHEREAS, the proposed text amendments are attached hereto and on file in the office of the City Clerk.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council shall consider the proposed adoption of Section 134-1281 and amendments to Sections 134-1087, 134-1122 and 134-1267 of the Zoning Ordinance of the Des Moines Municipal Code at a public hearing to be held in the Council Chambers at the Richard A. Clark Municipal Service Center (MSC), located at 1551 E. Martin Luther King, Jr. Parkway, Des Moines, Iowa, at 11:00 a.m. on June 2, 2017, at which time the City Council will hear both those who oppose and those who favor the proposal.
2. That the City Clerk is hereby authorized and directed to cause notice of said hearing in the accompanying form to be given by publication once, not less than seven (7) days and not more than twenty (20) days before the date of hearing, all as specified in Section 362.3 and Section 414.4 of the Iowa Code.
