SET HEARING FOR CONVEYANCE OF AN EASEMENT FOR OVERHEAD AND UNDERGROUND ELECTRIC LINES LOCATED WITHIN WAVELAND GOLF COURSE TO MIDAMERICAN ENERGY COMPANY FOR \$2,220.00

WHEREAS, MidAmerican Energy Company ("MidAmerican") has requested an easement on Cityowned property located within Waveland Golf Course as a part of the Waveland Townhomes project to relocate and replace existing underground and overhead electric lines to accommodate the new townhome development; and

WHEREAS, MidAmerican has offered to the City of Des Moines the purchase price of \$2,220.00 for the purchase of a permanent easement for an overhead and underground electric lines within said City-owned property to accommodate the electric lines relocation project, which purchase price reflects the fair market value of the easement as determined by the City's Real Estate Division; and

WHEREAS, the City and the public will not be inconvenienced by the sale and conveyance of the permanent easement as requested by MidAmerican.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa proposes to grant a 3,551 square foot permanent overhead and underground electric lines easement to MidAmerican Energy Company across City-owned property located within Waveland Golf Course, more specifically described below, for \$2,220.00:
