APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE REQUEST FOR PROPOSAL (RFP) PROCESS FOR GOOD CAUSE AND APPROVING RENEWAL AMENDMENT FOR AUTOMATED TRAFFIC ENFORCEMENT (ATE) SERVICES CONTRACT WITH GATSO USA, INC.

WHEREAS, Roll Call 10-1169, dated July 12, 2010, approved an RFP Evaluation and Selection Committee's Recommendation for Award of Contract for the Provision of Automated Electronic Speed and Red Light Enforcement Cameras & Citation Processing Services to GATSO USA Inc., and Authorizing the Police Department to Negotiate, and the City Manager to Execute, a Contract for the Provision of same; and

WHEREAS, the City of Des Moines Police Department wishes to utilize the same contract for the same purposes that City staff has negotiated such contract with GATSO USA, INC for an initial one year term with an additional one year renewal option, a copy of which is on file in the City Clerk's Office, and

WHEREAS, the City Manager recommends that the procurement of ATE services be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding for the \$26 per paid red light citation and the \$24 per paid speed citation is available from the Police Department's operating budget.


NOW, THEREFORE, BE IT RESOLVED, that the good cause has been shown to exempt the procurement of ATE services from the Procurement Ordinance competitive bidding requirements.

BE IT FURTHER RESOLVED that the Des Moines City Council hereby accepts and approves the procurement of ATE services for the Police Department under the above described GATSO USA, Inc. contract, a copy of which is in the City Clerk's Office, and the City Manager is authorized and directed to execute such contract on behalf of the City and renewal thereof.
