APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR STORM SEWER IMPROVEMENTS, SUMMERSFIELD PLAT 3,
BETWEEN MCANINCH CORPORATION AND SUMMERSFIELD, LLC

WHEREAS, on October 10, 2016 under Roll Call No. 16-1697, the City Council approved a private construction contract in the amount of \$72,876.00, between McAninch Corporation, Douglas D. McAninch, President/COO, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and Summersfield, LLC, Rick J. Tollakson, President and CEO, 6900 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Storm Sewer Improvements described as construction of storm sewer improvements to service the proposed revised Summersfield Plat 3 on E. 48th Street, north of E. Merced Street, constructed in accordance with Plan File Nos. 563-168/172, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$72,876.00, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and Summersfield, LLC, which were approved under Roll Call No. 16-1697, dated October 10, 2016, be received and filed; and that completion of said Storm Sewer Improvements described as construction of storm sewer improvements to service the proposed revised Summersfield Plat 3 on E. 48th Street, north of E. Merced Street, constructed in accordance with Plan File Nos. 563-168/172, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.




