HEARING FOR CONVEYANCE OF AN UNDERGROUND ELECTRIC EASEMENT ACROSS A PORTION OF GLENDALE CEMETERY TO MIDAMERICAN ENERGY COMPANY FOR \$1.00

WHEREAS, MidAmerican Energy Company ("MidAmerican") has requested an underground electric easement on City-owned property located within Glendale Cemetery in order to provide electric service to City buildings located in the Cemetery; and

WHEREAS, because the City of Des Moines requested the electric service and will benefit from said electric service there is no consideration to be paid by MidAmerican Energy Company for conveyance of the underground electric easement; and

WHEREAS, the City and the public will not be inconvenienced by the conveyance of the permanent underground electric easement as requested by MidAmerican Energy Company; and

WHEREAS, on July 24, 2017, by Roll Call No. 17-1238, it was duly resolved by the City Council that the proposed conveyance of the easement be set down for hearing on August 14, 2017, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of the proposal to convey the permanent underground electric easement was given as provided by law, setting forth the time and place for hearing on the proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of the permanent underground electric easement described below are hereby overruled and the hearing is closed.
- 2. The public would not be inconvenienced by reason of the conveyance of a permanent underground electric easement, more specifically described below, within said City-owned property in order to provide electric service to City buildings located in Glendale Cemetery, and the conveyance of said easement is hereby approved:
