AUTHORIZATION FOR THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY TO PROCEED WITH ACQUISITION OF ADDITIONAL STREET RIGHT-OF-WAY IN THE CITY'S NAME AS PART OF THE WRA EASTSIDE INTERCEPTOR – PHASE 27, SEGMENT 3 PROJECT BY GIFT, NEGOTIATION, OR EMINENT DOMAIN AND ACCEPTANCE OF ASSOCIATED REAL ESTATE DOCUMENTS

WHEREAS, on January 17, 2017, by WRA Board Resolution No. 17-11, the Des Moines Metropolitan Wastewater Reclamation Authority ("WRA") Board authorized acquisition of the necessary property interests for the WRA Eastside Interceptor – Phase 27, Segment 3 Project ("Project") by gift, negotiation or eminent domain; and

WHEREAS, as part of the Project, the WRA will need to acquire additional City right-of-way to allow for the replacement of existing sidewalks that need to be brought up to code through the installation of curb ramps and other American with Disability Act improvements; and

WHEREAS, the WRA, acting by and through its Operating Contractor, the City of Des Moines, will acquire the necessary additional right-of-way for this project in the City's name and the WRA will pay for all associated acquisition costs; and

WHEREAS, after the design is completed and property interest needs are determined, the proposed Fair Market Value of the property interests to be acquired will be submitted to the WRA Board or the WRA Director, as applicable, for approval and authorization to proceed with acquisitions.

WHEREAS, the permanent property interests to be acquired for this project will be used as City right-of-way following acquisition thereof, except for land determined to be excess by the City Engineer.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. That the Des Moines Metropolitan Wastewater Reclamation Authority be and is hereby authorized to proceed with the necessary activities and negotiations to acquire additional street right-of-way in the City's name by gift, negotiation, or condemnation as required for construction of the WRA Eastside Interceptor Phase 27, Segment 3 Project.
- 2. That the property will be acquired in accordance with the guidelines of 49 CFR Part 24 of the Uniform Relocation and Real Property Acquisition Act, as revised, and that the WRA is hereby authorized to offer relocation assistance as applicable.
