WHEREAS, on April 11, 2016 under Roll Call No. 16-0545, the City Council approved a private construction contract in the amount of \$23,683.00, between Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 - as Contractor, and Hy-Vee Construction, LC, James Bradshaw Strehlow, 5605 NE 22nd Street, Des Moines, IA, 50313 - as Owner, for construction of Signals Improvements described as signal installations at the northeast and southeast corners of 5th and Cherry Streets and associated miscellaneous items, in accordance with the contract documents including Plan File Nos. 563-02/03, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


