WHEREAS, the Park & Recreation Department requested the Finance Department Procurement Division to solicit bids for a two (2) year contract with three (3) additional one year renewal options to furnish city wide mowing and trimming services; and

WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V18-027 to eighteen (18) potential bidders with five (5) bids received; and

WHEREAS, the low dollar compliant bid for Areas 2, 5, 6.3, 6.4, 8, 9, 10 and 11 was received from Beautiful Lawns by Long's LLC, 911 SE 14TH Street, Des Moines, IA 50317, Brandon Long, Owner; and

WHEREAS, the low dollar compliant bid for Area 7 was received from ADA Mowing, 4432 Orchard Drive, Pleasant Hill, IA 50327, Joel Huggins, Owner; and

WHEREAS, the low dollar compliant bid for Areas 1 and 3 was received from Hyde Mowing & Snow Removal LLC, 5605 NW 62nd Ave., Johnston, IA 50131 Sharon Hyde, Owner; and

WHEREAS, the low dollar compliant bid for Areas 6.1 and 6.2 was received from Stamper Lawn Care, 5611 SW 2nd Street, Des Moines, IA 50315, Cody Stamper, Owner; and

WHEREAS, funding is available from various departmental operating budgets at an annual estimated amount of \$773,721.00; and

WHEREAS, the Procurement Administrator and the Park & Recreation Department recommends approval of the low dollar compliant bids for mowing and trimming services;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to the aforementioned bidders, and further authorizes the Procurement Administrator to execute agreements with an initial term of two years renewable for three (3) additional twelve (12) month periods at an annual estimated cost of \$773,721.00, with price increases complying with agreement terms.
