**APPROVING AND AUTHORIZING THE EXECUTION OF DEPARTMENT OF
TRANSPORTATION AGREEMENT FOR THE TIGER DISCRETIONARY GRANT FOR
THE BRIDGES TO OPPORTUNITY: DES MOINES' COMMUNITY CONNECTION
PROJECT**

WHEREAS, the FY2016 Appropriations Act appropriated \$500 million to be awarded by the Department of Transportation for National Infrastructure Investments. Due to the similarity to previous appropriation for the Transportation Investment Generating Economic Recovery, or "TIGER Discretionary Grant", DOT is referring to the grants for National Infrastructure Investments under the FY 2016 Appropriations Act simply as "TIGER Discretionary Grants"; and

WHEREAS, on April 11, 2016, by Roll Call 16-0542, City Council authorized submitting an application for the TIGER Discretionary Grant for the Bridges to Opportunity: Des Moines' Community Connection Project; and

WHEREAS, on July 26, 2016, the U.S. Transportation Secretary announced the projects selected to receive funding from the TIGER 2016 program, including \$8 million for the Bridges to Opportunity: Des Moines' Community Connection Project; and

WHEREAS, the TIGER Grant Agreement has been provided by the U.S. Department of Transportation, Federal Highway Administration; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the Grant Agreement between the City of Des Moines, US Department of Transportation, Federal Highway Administration and the Iowa Department of Transportation, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to execute the TIGER Grant Agreement and any other related documents for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is hereby authorized to administer the terms of said Agreement and all amendments thereto, and to approve and execute further amendments or other documents pertaining to minor or unsubstantial changes to said Agreement, following approval of the City's Legal Department as to form.
