WHEREAS, the Fleet Maintenance Division of the City Manager's Office requested the Finance Department Procurement Division to order eleven (11) replacement truck chassis, plus snow and ice control equipment to be outfitted on nine (9) of the chassis, for use by the Street Maintenance and Sewers Divisions of the Public Works Department, and the Park and Recreation Department; and

WHEREAS, truck chassis have been competitively bid and are available from Housby Mack Inc., 4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, President, per Houston-Galveston Area Council (HGAC) contract HT06-16 in the amount of \$1,390,385.00; and

WHEREAS, snow and ice control equipment has been competitively bid and is available from Henderson Products, 916 South 10th Street, Manchester, IA 52057, Jon Sievert, President, per National Joint Powers Alliance (NJPA) contract 080114-HPI in the amount of \$668,439.70; and

WHEREAS, Municipal Code section 2-726(m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, \$1,486,209.70 of the funding is available from CM024021/Equipment Replacement, and \$572,625.00 of the funding is available from PW247713/Storm Sewer Maintenance.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the HGAC contract purchase of eleven (11) replacement truck chassis from Housby Mack, and also accepts and approves the NJPA contract purchase of snow and ice control equipment to outfit nine (9) of the aforementioned truck chassis, at a grand total cost of \$2,058,834.70.
