APPROVAL OF AGREEMENT BETWEEN CITY OF DES MOINES, POLK COUNTY CONSERVATION BOARD, AND IOWA DEPARTMENT OF NATURAL RESOURCES FOR DONATION AND DEPOSIT OF FILL SOIL AT RIVERVIEW PARK

WHEREAS, Polk County Conservation Board (PCCB) is in the process of improving Easter Lake and the Easter Lake Watershed, which includes the removal of sediment from Easter Lake; and

WHEREAS, PCCB and the Iowa Department of Natural Resources (DNR) have entered into an agreement for the dredging and shoreline restoration of Easter Lake, which requires the dredging and removal of clay soils which are suitable for fill; and

WHEREAS, the City is in need of approximately 60,000 cubic yards of fill soil at Riverview Park and PCCB and DNR desire to deposit approximately 60,000 cubic yards of such removed dredge soil in Riverview Park; and

WHEREAS, the City, PCCB, and DNR have negotiated a proposed Agreement to Donate the Loading/Excavation and Hauling of Clay Fill Soils to Riverview Park, in which the DNR's contractor for the Easter Lake project will haul and deposit such fill soil at Riverview Park, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the above described Agreement Between the City of Des Moines and Iowa Department of Natural Resources and Polk County Conservation Board to Donate the Loading/Excavation and Hauling of Clay Fill Soils to Riverview Park, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to sign said Agreement on behalf of the City and the City Clerk is directed to attest to his signature.
