**APPROVING EXCEPTION TO REQUEST FOR PROPOSAL PROCESS
FOR GOOD CAUSE AND APPROVING A
PROFESSIONAL SERVICES AGREEMENT WITH
SIMONSON & ASSOCIATES, L.L.C. FOR
DESIGN AND CONSTRUCTION PHASE SERVICES FOR THE
JAMES W. COWNIE SPORTS COMPLEX SIGNAGE IMPROVEMENTS,
NOT TO EXCEED \$71,500**

WHEREAS, Simonson and Associates Architects, L.L.C. donated in-kind design services to generate signage images for the James W. Cownie Sports Complex Signage Improvements (hereinafter Project) for fundraising purposes and raising public awareness of the proposed signage; and

WHEREAS, for project design and schedule efficiencies, the City Engineer recommends that Simonson and Associates Architects, L.L.C. be retained for this Project; and

WHEREAS, the City Engineer recommends that the procurement of professional services for the James W. Cownie Sports Complex Signage Improvements be exempted from the requirements of the Engineering Department's Request for Proposal (RFP) process and advertising requirement for good cause shown, pursuant to Section 2-726(b)(1)(a) of the Municipal Code of the City of Des Moines.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That good cause has been shown to exempt the procurement of the above described services from the requirements of the Engineering Department's RFP process and the advertising requirement of such Section.

BE IT FURTHER RESOLVED: That Professional Services Agreement between the City of Des Moines and Simonson and Associates Architects, L.L.C., for a lump sum amount of \$65,000 and reimbursable costs not to exceed \$6,500, to provide professional services for the James W. Cownie Sports Complex Signage Improvements, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.
