NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that the Mayor and City Clerk, as appropriate, are hereby authorized and directed to certify the Municipal Housing Agency's amended annual budget for all projects for the fiscal year ending June 30, 2018 and to certify the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2019 on the forms on file in the Office of the City Clerk and the Acting Director of Housing Services is hereby directed to submit such certification to the U.S. Department of Housing and Urban Development.
