RESOLUTION TO REINSTATE ACCENT NEIGHBORHOOD IN THE NEIGHBORHOOD REVITALIZATION PROGRAM AS A RECOGNIZED NEIGHBORHOOD

WHEREAS, on May 24, 1993, by Roll Call No. 93-2026, the City Council approved the Neighborhood Recognition Policy which establishes procedures for the formal recognition of neighborhoods by the City of Des Moines, and authorizes recognized neighborhoods to advise the City on issues of concern; and

WHEREAS, on November 8, 1993, by Roll Call No. 93-2026, the ACCENT Neighborhood was formally recognized by the City of Des Moines; and

WHEREAS, on June 26, 2017, by Roll Call No. 17-1044, the City Council approved to suspend ACCENT Neighborhood from the list of recognized neighborhoods for six months, to allow the neighborhood time to reorganize rather than immediately be removed from the list of recognized neighborhoods; and

WHEREAS, on February 5, 2018, by Roll Call No. 18-0191, the City Council approved to extend the suspension of ACCENT Neighborhood until August 5, 2018, to provide additional time for reorganization; and

WHEREAS, the ACCENT Neighborhood has reorganized its membership and Board and requested to be reinstated into the Neighborhood Revitalization Program as a Recognized Neighborhood with expanded boundaries; and

WHEREAS, on June 6, 2018, the Neighborhood Revitalization Board voted to recommend to the City Council that the City of Des Moines reinstate the ACCENT Neighborhood as a Recognized Neighborhood in the Neighborhood Revitalization Program with expanded boundaries, as proposed

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the ACCENT Neighborhood be and is hereby reinstated as a Recognized Neighborhood in the Neighborhood Revitalization Program with expanded boundaries as proposed, effective immediately.
