Schipper, Principal, 3716 Ingersoll Avenue, Suite A, Des Moines, Iowa, 50312, for a total cost not to exceed \$105,330, based on hourly rates, to provide design phase services and construction phase services for Riverview Park, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreement for and on behalf of the City of Des Moines, Iowa.
