PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON SW 9TH STREET REHABILITATION FROM WALL AVENUE TO ARMY POST ROAD RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS GRIMES ASPHALT AND PAVING CORPORATION, KURT RASMUSSEN, PRESIDENT, \$738,062.00

WHEREAS, on June 11, 2018, under Roll Call No. 18-0957, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

SW 9th Street Rehabilitation from Wall Avenue to Army Post Road, 06-2018-009

The improvement includes street rehabilitation by milling the existing roadway, resurfacing with Hot Mix Asphalt (HMA), partial depth HMA patching, full depth Portland Cement Concrete (PCC) pavement patching, pavement markings, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 596-238/259, located on S.W. 9th Street between Wall Avenue and Army Post Road, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED. That sealed bids for said improvement were submitted by the following bidders:

- OMG Midwest, Inc. dba Des Moines Asphalt & Paving Ankeny, IA

- Hawkeye Paving Corporation Bettendorf, IA

which were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on June 26, 2018. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.


