APPROVE EXPANSION OF WATROUS HEIGHTS NEIGHBORHOOD BOUNDARIES IN ACCORDANCE WITH THE NEIGHBORHOOD RECOGNITION POLICY

WHEREAS, on May 24, 1993, by Roll Call No. 93-2026, the City Council approved the Neighborhood Recognition Policy which establishes procedures for the formal recognition of neighborhoods by the City of Des Moines, and authorizes recognized neighborhoods to advise the City on issues of concern; and

WHEREAS, on August 28, 2017, by Roll Call No. 17-1461, the City Council approved designation of the Watrous Heights Neighborhood as a Recognized Neighborhood for the City of Des Moines; and

WHEREAS, the Watrous Heights Neighborhood has requested to expand its boundaries to the north 1/4 section to include S. W. 9th Street between Park Avenue and McKinley Avenue on the west, S. Union Street between Park Avenue to McKinley Avenue on the east, Park Avenue between S.W. 9th Street and S. Union Street on the north, and McKinley Avenue between S.W. 9th Street to S. Union Street on the south; as specifically shown in the accompanying map; and

WHEREAS, on July 11, 2018, the Neighborhood Revitalization Board voted to recommend to the City Council that the City of Des Moines expand the boundaries of Watrous Heights Neighborhood as proposed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the boundaries of the Watrous Heights Neighborhood be hereby expanded to include S. W. 9th Street between Park Avenue and McKinley Avenue on the west, S. Union Street between Park Avenue to McKinley Avenue on the east, Park Avenue between S.W. 9th Street and S. Union Street on the north, and McKinley Avenue between S.W. 9th Street to S. Union Street on the south, and in accordance with the Neighborhood Recognition Policy, effective immediately.
