RESOLUTION SETTING DATE OF PUBLIC HEARING ON THE PROPOSED FIFTH AMENDMENT TO THE URBAN RENEWAL PLAN FOR THE SOUTHSIDE ECONOMIC DEVELOPMENT DISTRICT URBAN RENEWAL AREA

WHEREAS, on December 6, 2010, by Roll Call No. 10-2020, the City Council approved the Southside Economic Development District Urban Renewal Plan (the "Plan") for the area (the "Urban Renewal Area") bounded on the north by Army Post Road and E. Army Post Road, on the east by SE 14th Street, on the south by the Polk County line, and on the west by SW 9th Street, which plan has previously been amended four times; and,

WHEREAS, the purpose of the proposed Fifth Amendment to the Southside Economic Development District Urban Renewal Plan (the "Fifth Amendment"), which is on file and available for inspection in the office of the City Clerk, is:

- To add a new Appendix B - Approved Public Buildings, Infrastructure and other Improvements to identify the construction of a new animal control facility as a public improvement project to be undertaken within the Southside Economic Development District Urban Renewal Area on City-owned property west of Chaffee Road along the private street known as Rogers Road; and,
To update the Financial Condition Report; and,

WHEREAS, the Urban Design Review Board is scheduled to review the proposed Fifth Amendment at its regular meeting on August 14, 2018, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- A public hearing shall be held before the City Council to consider the proposed Fifth Amendment at 5:00 p.m. on September 10, 2018, in the Council Chambers at City Hall.
The City Clerk is authorized and directed to publish notice of said public hearing by publication in the Des Moines Register on August 23, 2018.
The proposed Fifth Amendment is hereby submitted to the Urban Design Review Board for its review and recommendation, with said written recommendation requested to be received by the City Council prior to the date of public hearing.
The City Manager or his designee is hereby designated as the City's representative to the consultation proceedings with the Des Moines Independent School District, Polk County, Des Moines Area Community College, and Des Moines Area Regional Transit Authority. The

The City Manager shall cause notice of the consultation meeting, a copy of the Fifth Amendment and a copy of the Notice of Public Hearing to be mailed to each such affected taxing entity.
