WHEREAS, on July 10, 2017 under Roll Call No. 17-1142, the City Council approved a private construction contract in the amount of \$17,435.25, between Spring Lake Construction, Inc., Dean Quirk, Owner, 4123 NW 95th Place, Polk City, IA, 50226 - as Contractor, and T and M Ventures, LLC, Kit Curry, Owner, 601 S. 28th Street, West Des Moines, IA, 50266 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements located in Beaver Cove, located at 4209 Lower Beaver Road, as shown on Plan File Nos. 564-075/077, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.




