WHEREAS, the Fleet Maintenance Division of the Finance Department requested the Finance Department Procurement Division to order forty-five (45) replacement vehicles for use by various City Departments; and

WHEREAS, five (5) assorted vehicles have been competitively bid and are available from Stivers Ford, 1450 E. Highway 6, Waukee, IA 50263, Scott Politte, General Manager, per State of Iowa Contract 19095, at a total cost of \$136,675.00; and

WHEREAS, two (2) assorted vehicles have been competitively bid and are available from Karl Chevrolet, 1101 SE Oralabor Road, Ankeny, IA 50021, Carl Moyer, Owner, per State of Iowa Contract 19096, at a total cost of \$53,818.38; and

WHEREAS, twenty-seven (27) assorted vehicles have been competitively bid and are available from Stew Hanson Dodge City, 12103 Hickman Road, Des Moines, IA 50323, Dan Boettcher, General Manager, per State of Iowa Contract 19098, at a total cost of \$645,236.00; and

WHEREAS, eleven (11) assorted vehicles have been competitively bid and are available from Dewey Ford, 3055 SW Delaware, Ankeny, IA 50021, Dan Boettcher, General Manager, per State of Iowa Contracts 18129 and 19097, at a total cost of \$382,346.28; and

WHEREAS, funding is available from various Equipment Replacement budgets; and

WHEREAS, Municipal Code section 2-726(k) provides for the purchase of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Division; and

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the State of Iowa contract purchase of forty-five (45) replacement vehicles from the aforementioned car dealers at a total cost of \$1,218,075.66.
