WHEREAS, the Fleet Maintenance Division of the City Manager's Office requested the Finance Department Procurement Division to order twelve (12) replacement single-axle truck chassis, plus snow and ice control equipment to be outfitted on sixteen (16) truck chassis (four (4) tandem-axle truck chassis to be awarded in the future), for use by the Street Maintenance Division of the Public Works Department; and

WHEREAS, truck chassis have been competitively bid and are available from Housby Mack Inc., 4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, President, per Houston-Galveston Area Council (HGAC) contract HT08-18 in the amount of \$1,558,620.00; and

WHEREAS, snow and ice control equipment has been competitively bid and is available from Henderson Products, 916 South 10th Street, Manchester, IA 52057, Jon Sievert, President, per Sourcewell Cooperative purchasing contract 080114-HPI in the amount of \$1,538,889.80; and

WHEREAS, Municipal Code section 2-726(m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, funding is available from FN024882/Street Maintenance Equipment Replacement.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the HGAC contract purchase of twelve (12) replacement truck chassis from Housby Mack, and also accepts and approves the Sourcewell contract purchase of snow and ice control equipment to outfit sixteen (16) truck chassis, at a grand total cost of \$3,097,509.80.
