APPROVAL OF AGREEMENT WITH MIDAMERICAN ENERGY COMPANY FOR PLAZA SIGN AND SPONSORSHIP AT JAMES W. COWNIE SOCCER PARK AND AUTHORIZING USE OF SOCCER PARK AND CITY NAME AS A SPONSOR OF THE SOCCER PARK

WHEREAS, the City of Des Moines owns and operates the James W. Cownie Soccer Park as a public facility to provide a facility for use by area teams and to host local, regional, and national events that provide economic impact to the city; and

WHEREAS, MidAmerican Energy Company has participated in the development of the Cownie Soccer Park, along with the City, by making charitable donations between 2005 – 2014 in the amount of \$700,000 to the Community Foundation of Greater Des Moines (CFGDM) fund used for donations to the City for development and maintenance of the facility and also additional funds to the CFGDM fund used for the James W. Cownie Soccer Park directional signage at Hartford and East 14<sup>th</sup> Street; and

WHEREAS, in recognition of such generous contributions, since at least 2005, the MidAmerican Energy Company name and logo has been stamped into the asphalt ground surface of the "Play It Safe Plaza" as a type of donor recognition plaque; and

WHEREAS, MidAmerican Energy Company desires that a new sign be installed with the MidAmerican name and logo and the slogan "Obsessively, Relentlessly At Your Service" at the "Play It Safe Plaza" in the James W. Cownie Soccer Park and Park and Recreation Department staff have negotiated an agreement providing for such sign to be designed, fabricated and installed with the costs to be paid by funds from the Community Foundation of Greater Des Moines to be on display until December 23, 2034, subject to compliance with the City's Policy for Naming of Streets, Facilities and Park Land in the City of Des Moines ("Policy"); and

WHEREAS, the City Council finds that appropriate circumstances exist to make an exception to and to waive the procedures of the Policy and to consider allowing a sign at the "Play It Safe Plaza" to bear the MidAmerican Energy Company name, logo, and slogan.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the James W. Cownie Sports Park Sponsorship Agreement, as described above, a copy of which is available in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to execute said agreement on behalf of the City and the City Clerk is directed to attest to his signature.

BE IT FURTHER RESOLVED that a sign at the Plaza may bear the MidAmerican Energy name, logo and slogan until December 23, 2034, subject to approval of such sign by the Park and Recreation Director.
