PROCESS FOR GOOD CAUSE AND APPROVING A

WHEREAS, the City Engineer recommends that the procurement of professional services for the Market District Sanitary Sewer Improvements, be exempted from the requirements of the Engineering Department's Request for Proposal (RFP) process and advertising requirement for good cause shown, pursuant to Section 2-726(b)(1)(a) of the Municipal Code of the City of Des Moines.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Professional Services Agreement between the City of Des Moines and Veenstra & Kimm, Inc., for a total cost not to exceed \$104,464 based on hourly rates, to provide professional services for the Market District Sanitary Sewer Improvements, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Professional Services Agreement for and on behalf of the City of Des Moines, Iowa.
