PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON FIRE STATION NO. 3 IMPROVEMENTS; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS TRINITY CONST. GROUP, LLC., JACKIE GOODE, VICE PRESIDENT, \$62,009.00

WHEREAS, on January 28, 2019, under Roll Call No. 19-0110, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Fire Station No. 3 Improvements, 10-2019-007

This improvement includes the replacement of the steel stair and the shoring of the tunnel under the apparatus bay floor; all in accordance with the contract documents, including Plan File Nos. 607-043-049, located at 2458 Easton Boulevard, Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

Ray Drive, Des Moines, Iowa at 11:00 a.m. on February 12, 2019. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Trinity Construction Group, LLC, Jackie Goode, Vice President, 204 SW 2nd Street, Suite 200, Des Moines, IA, 50309 in the amount of \$62,009.00, and said bid be and the same is hereby accepted.




