CONDITIONALLY APPROVING FINAL SUBDIVISION PLAT OF PARKSIDE ESTATES  
PLAT 1

WHEREAS, the final subdivision plat entitled Parkside Estates Plat 1, for land in the vicinity of 150 E. County Line Road, to be developed by Solid Ground, LLC, 17369 Berkshire Parkway, Clive, IA 50325, Eric Grubb, Officer, was submitted to the Community Development Department on February 26, 2019; and,

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on December 21, 2017; and,

WHEREAS, the Permit and Development Center has recommended conditional approval of the final subdivision plat, subject to acceptance of final legal documents by the City Legal Department; and,

WHEREAS, subject to the conditions identified below, the said subdivision plat conforms to Iowa Code Sections 355.8, 354.6, and 354.11, and said subdivision plat conforms to the standards and conditions set forth in Chapter 106 of the Municipal Code of the City of Des Moines, Iowa; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. It is hereby determined that the subdivision plat identified above conforms to the PlanDSM: Creating Our Tomorrow Plan and the subdivision, with the required installation of public improvements, will not unduly burden public improvements in the area and will provide an appropriate balance of interests between current proprietors, future purchasers and the public interest.
2. The subdivision plat entitled Parkside Estates Plat 1 is hereby approved, and an irrevocable letter of credit number 1347 from West Bank, in the amount of \$160,375 has been received for the completion of the required public improvements and sidewalks within the plat, and approval of the same by the City Legal Department.
3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
4. The City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Developer for delivery to the County Recorder for recording by the plat proprietors. The City Clerk is hereby further directed to send a copy of the subdivision plat to the Board of Education, Century Link Communications, Mid-American Energy, Mediacom, Des



The Permanent Easements for public utilities, sanitary sewer, storm sewer, surface water flowage, detention, geothermal, and trails have been provided incident to the said subdivision plat are hereby approved and accepted, and the City Clerk is hereby authorized and directed to certify to the City's acceptance on each such easement.




