RESOLUTION APPROVING AMENDMENT TO EIGHTH AND MULBERRY PARKING LICENSE AGREEMENT AND AMENDMENT TO REDEVELOPMENT AGREEMENT WITH WELLS FARGO PROPERTIES, INC.

WHEREAS, by Roll Call No. 03-2898 of December 22, 2003, the City Council approved a Redevelopment Agreement with Wells Fargo Financial, Inc. for the expansion of its home office facility within the block bounded by Walnut, Locust, Eighth and Ninth Streets; and

WHEREAS, by Roll Call No. 14-0064 of January 13, 2014, the City Council approved the Eighth and Mulberry Parking License Agreement with Wells Fargo Bank, N.A. for the license of parking spaces in the Garage; and

WHEREAS, all interests under the Redevelopment Agreement and the Parking License Agreement have been assigned by the Wells Fargo entities to Wells Fargo Properties, Inc. ("Wells Fargo"); and

WHEREAS, it is contemplated that the City will consider the sale of the Eighth and Mulberry Parking Garage and accordingly it is appropriate to extend the Parking License Agreement on a month-to-month basis and to delete terms in the Redevelopment Agreement relating to a potential option for Wells Fargo to lease parking spaces in a City parking garage.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Amendment to Eighth and Mulberry Parking License Agreement in the general form on file in the Office of the City Clerk, with such changes as may be agreed to by the City Manager and the Legal Department, is hereby approved and the Mayor is hereby authorized and directed to sign the Amendment on behalf of the City and the City Clerk is directed to attest to the Mayor's signature.
