## SETTING DATE OF PUBLIC HEARING ON THE PROPOSED TWENTY-FOURTH AMENDMENT TO THE METRO CENTER URBAN RENEWAL PLAN

WHEREAS, on March 20, 2000, by Roll Call Nos. 00-788 and 00-789, the City Council adopted the Urban Renewal Plan for the Metro Center Urban Renewal Project, and such Plan has been amended twenty-three times (the urban renewal plan as so amended is herein referred to as the "Plan"); and,

WHEREAS, the Metro Center Urban Renewal Project Area encompasses an irregularly shaped area that includes the downtown core and the areas surrounding the downtown core; and,

WHEREAS, the purpose of the proposed Twenty-Fourth Amendment to the Plan, attached hereto as Exhibit "A", is to (a) approve the provision of financial assistance from tax increment revenues in the Metro Center Urban Renewal area for redevelopment projects including revised provision of financial assistance under new replacement development agreement for the senior multi-family residential building development at 401 S.E. 6<sup>th</sup> Street/400 S.E. 7<sup>th</sup> Street known as Connolly Lofts; revised provision of financial assistance for the mixed-use residential tower commercial space and parking structure development at 5th and Walnut Street known as the Fifth; revised provision of financial assistance for the single and multi-family urban residential development west of S.W. 11th Street and north of the Raccoon River known as Gray's Station; historic renovation and commercial redevelopment at 401 East Court Avenue; and additional financial assistance for enhanced operation, management and maintenance of the Botanical Center on Robert D. Ray Drive; (b) approve certain public improvement, streets and parking projects for funding from tax increment revenues in the Metro Center Urban Renewal Area including the downtown Market District study, Downtown paving, Skywalk system repairs and improvements, Downtown walkability improvements, continuing planning, oversight and administration of the Metro Center Urban Renewal Project and update and revise funding amounts and schedules for previously approved public improvement projects; (c) update the Financial Condition Report to reflect the approved tax increment funded projects; (d) incorporate an updated analysis of alternative development options and funding to use of tax increment revenues for public buildings including Principal Park improvements; and (e) edit text related to approved public improvements; and.

WHEREAS, the Urban Design Review Board shall review the proposed amendment at its regular meeting on April 16, 2019, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council.
