SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY LOCATED EAST OF AND ADJOINING 901 SOUTHEAST 7TH STREET TO ANCHOR INVESTMENT GROUP, LLC FOR \$75.00

WHEREAS, on October 6, 1986, by Roll Call No. 4761, the City Council of the City of Des Moines, Iowa voted to approve the vacation of all of the north-south alley right-of-way lying West of and adjoining Lots 9 and 10, Block 70, Town of De Moin; and

WHEREAS, also in 1986, by Roll Call No. 5025, the City Council of the City of Des Moines, Iowa voted to approve the sale of the east half of said vacated alley right-of-way; and

WHEREAS, Anchor Investment Group, LLC, owner of 901 Southeast 7th Street, has offered to the City of Des Moines ("City") the purchase price of \$75.00 for the purchase of the west half of the vacated alley right-of-way lying east of and adjoining its property at 901 Southeast 7th Street (hereinafter "Property"), for assemblage with 901 Southeast 7th Street, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to sell the west half of the vacated alley right-of-way lying east of and adjoining 901 Southeast 7th Street, as legally described, to the grantee, and for the consideration identified below, subject to a reservation of easements therein:

Grantee: Anchor Investment Group, LLC Consideration: \$75.00 Legal Description: THE WEST HALF OF THE VACATED NORTH/SOUTH ALLEY RIGHT-OF-WAY LYING EAST OF AND ADJOINING LOTS 1 AND 2, BLOCK 70, TOWN OF DE MOINE, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA; AND CONTAINING APPROXIMATELY 1,008 SQUARE FEET.
