APPROVING SECOND AMENDMENT TO PAYMENT IN LIEU OF TAXES (PILOT) AGREEMENT TO WAIVE PILOT PAYMENTS FOR TWO YEARS FOR THE DES MOINES SOCIAL CLUB

WHEREAS, on October 22, 2012, by Roll Call No. 12-1643, the City Council approved a Development Agreement between the City and Des Moines Social Club ("Development Agreement") for the restoration and renovation of the Old Central Fire Station No. 1 located at 900 Mulberry Street ("Property"); and

WHEREAS, in accordance with the terms of the Development Agreement, as amended, the City and the Des Moines Social Club entered into an Agreement for Payment in Lieu of Taxes dated March 8, 2013 ("PILOT Agreement"), in connection with the Property; and

WHEREAS, on June 23, 2014, by Roll Call No. 14-0967, the City Council approved the Second Amendment to Development Agreement and related documents including the First Amendment and Joinder to PILOT Agreement to acknowledge transfer of the Property to DMSC Building and to confirm that both DMSC Building and Des Moines Social Club are bound by and remain liable for all payments and obligations under the PILOT Agreement; and

WHEREAS, in recognition of substantial improvements to be performed by DMSC Building and Des Moines Social Club with respect to the Property, it is in the best interests of the City for the City to agree to a temporary two-year waiver of PILOT payments for the Property as set out in the Second Amendment to PILOT Agreement on file in the Office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Second Amendment to PILOT Agreement on file in the Office of the City Clerk is hereby approved and the Mayor is hereby authorized and directed to sign the Second Amendment on behalf of the City and the City Clerk is directed to attest the Mayor's signature.

BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to file the fully executed Second Amendment in the Office of the Polk County Recorder.
