WHEREAS, on March 25, 2019, under Roll Call No. 19-0448, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2019-2020 HMA Pavement Scarification and Resurfacing, 06-2019-010

The improvement includes scarification only of 2-inch average depth of asphalt street surfaces with specified milling machine and equipment in a cooperative effort with the City of Des Moines Public Works Department, together with other incidental and related work; all in accordance with the contract documents at the following locations within the City of Des Moines:

S.W. 12th Street from Davis Avenue to Edgemont Street 13th Street from University Avenue to Forest Avenue E. 13th Street from Thompson Avenue to Arthur Avenue 29th Street from High Street to Woodland Avenue Creston Avenue from S.W. 12th Street to S.W. 14th Street Madison Avenue from 6th Avenue to 11th Street Walnut Street from 10th Street to 12th Street Woodland Avenue from Polk Boulevard to 49th Street

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That the Engineer is hereby directed to secure execution by the lowest responsible, responsive Bidder and its surety of the contract documents in the form heretofore approved by this Council; that the Engineer is directed to thereafter present said contract documents to this Council for approval and authorization to the Mayor to sign; and that no contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary road closures for the Project.
