ORDERING CONSTRUCTION OF 2019 PCC PAVEMENT PATCHING PROGRAM AND FIXING A DATE FOR RECEIVING OF BIDS ON JUNE4, 2019 AND PUBLIC HEARING ON JUNE 24, 2019 ENGINEER'S ESTIMATE IS \$2,160,000.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

2019 PCC Pavement Patching Program, 06-2019-009


The improvement includes removals, drilling & doweling, furnishing, placing, curing, sawing, sealing Portland Cement Concrete (PCC) pavement patches of various thickness, and other incidental items; in accordance with the contract documents, including Plan File Nos. 611-036/059, at the following locations in the City of Des Moines, Iowa:

Rittenhouse Street – 2301 Rittenhouse Street Emma Avenue - S.W. 9th Street to S.W. 14th Street Lewis Avenue - S.W. 9th Street to S.W. 14th Street Wolcott Avenue - S.W. 31st Street to S.W. 37th Street Cummins Pkwy - Windsor Drive to University Avenue Vermont Avenue- Indiana Avenue to College Avenue E. 38th Court - Easton Boulevard to Sheridan Avenue Pioneer Road - S.E. 8th Street to S.E. 14th Street S.E. 8th Street - Pioneer Road to Indianola Avenue King Avenue - S.E. 14th Street to S.E. 17th Street

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$2,160,000.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on June 24, 2019, at which time this Council will consider any objections offered thereto or to the making of said improvement.

Ray Drive, Des Moines, Iowa, at 11:00 a.m. on June 4, 2019, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its next meeting for action thereon.

BE IT FURTHER RESOLVED: That an appropriate Notice to Bidders for said improvement be posted, and Notice of Public Hearing for said improvement be published in the Des Moines Register, all as provided and directed by Chapter 26 and/or 314, Code of Iowa.
