RESOLUTION TO AUTHORIZE DEPOSIT OF CONDEMNATION AWARD FOR THE ACQUISITION OF PROPERTY INTERESTS LOCATED AT 3121 DEAN AVENUE FOR THE LEETOWN CREEKWAY CHANNEL IMPROVEMENT PROJECT

WHEREAS, on April 7, 2014 by Roll Call No. 14-0537, the City Council of the City of Des Moines, Iowa authorized the acquisition of all necessary property interests by gift, negotiation, or condemnation for the Leetown Creekway Channel Improvement Project; and

WHEREAS, on November 27, 2018, the City Manager established Fair Market Value on the following described property:

WHEREAS, the City's Real Estate Division was unable to negotiate a settlement on the above described property; and


WHEREAS, condemnation proceedings were subsequently instituted for the aforementioned property interests; and

WHEREAS, the Polk County Condemnation Commissioners convened on April 29, 2019, in Des Moines, Iowa; and

WHEREAS, the Sheriff's Office of Polk County has submitted the Notice of Appraisement of Damages and Time for Appeal; and

WHEREAS, pursuant to section 6B.25 of the Iowa Code, the award must be deposited with the Sheriff in order for the City to proceed to enter on to the property and take possession as is necessary for the project to proceed; and

WHEREAS, the City of Des Moines' Real Estate Division of the Engineering Department and the Legal Department recommend deposit of the Condemnation Commissioners' award payable to property owner(s) and all other payees and that other fees and condemnation expenses be deposited with the Sheriff in order to proceed with the project; and

WHEREAS, the City of Des Moines has a reasonable expectation that it will achieve a public purpose, comply with all applicable standards, and obtain all necessary permits in conjunction with this project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Council hereby authorizes the deposit of the condemnation award of \$257,500.00 payable to property owner(s) and all other payees for a Permanent Easement for Storm Sewer and Surface Water Flowage and a Temporary Easement for Construction and Construction-Related Activities on the aforementioned property plus condemnation fees in the amount of \$1,882.97, as certified by the Sheriff of Polk County.

That the Finance Director is authorized and directed to draw checks in the amounts set forth above for the deposit of the condemnation award and fees, as certified by the Sheriff of Polk County, Iowa, and to pay any unforeseen additional costs certified by the Legal Department and the Engineering Department; the Real Estate Division Manager is authorized and directed to obtain the checks needed to carry out this transaction and to deliver them to the Sheriff of Polk County and the Real Estate Division Manager is also charged with securing the proper receipts therefor.
