PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON MERLE HAY ROAD AND HICKMAN ROAD INTERSECTION IMPROVEMENTS, RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS MINTURN, INC., CLINTON M. RHOADS, PRESIDENT, \$742,822.50

WHEREAS, on April 8, 2019, under Roll Call No. 19-0535, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Merle Hay Road and Hickman Road Intersection Improvements, 06-2018-010 UST-006-4(187)--4A-77

The improvement includes construction of a second eastbound left-turn lane with new medians, sidewalk replacement, traffic signal replacement, Hot Mix Asphalt (HMA) overlay, new pavement markings, and incidental items; all in accordance with the contract documents, including Plan File Nos. 607-228/270, located at and near the intersection of Merle Hay Road and Hickman Road, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.


