APPROVAL OF AMENDMENT TO A. H. BLANK PARK ZOO LEASE, OPERATION, MANAGEMENT AND MAINTENANCE AGREEMENT BY AND BETWEEN THE CITY OF DES MOINES AND THE BLANK PARK ZOO FOUNDATION, INC.

WHEREAS, on April 25, 2011, by Roll Call No. 11-0712, the City Council approved a Lease, Operation, Management and Maintenance Agreement with the Blank Park Zoo Foundation, Inc. ("Zoo Foundation") in which the Zoo Foundation agreed to, in addition to other consideration, construct at its cost at least \$16,600,000.00 in improvements at the Zoo and the A. H. Blank Park ("Park"); and

WHEREAS, the Lease, Operation, Management and Maintenance Agreement ("Lease Agreement") provides that the Zoo Foundation will be responsible for the payment of all utilities, including water, in operation of the Zoo and the Park; and

WHEREAS, in its 53 years of operation, the Zoo has not been charged for water usage by Des Moines Water Works; and


WHEREAS, the Zoo Foundation and the City have recently been informed by Des Moines Water Works of its intention to begin billing for water usage at the Zoo upon installation of new water meters at the Zoo; and

WHEREAS, the Zoo Foundation and City staff have negotiated an Amendment to the Lease Agreement in which the Zoo Foundation agrees to pay for up to 20 percent of the total cost for water usage at the Zoo and Park and the City agrees to continue conditional annual payments of \$290,000 for Zoo operational expenses from hotel/motel tax funds during the renewal terms of the Lease Agreement, a copy of which is on file in the City Clerk's Office.

WHEREAS, the City and Zoo Foundation have agreed to the 20% charge, in part as a result of their best effort to attribute human consumption of water at the Zoo; for which the Zoo Foundation will begin paying. The 80% of the water charges is attributed to the care of the Zoo animals; which is a requirement of the American Zoo Association accreditation, which accreditation is required of the Blank Park Zoo Foundation by the terms of the Lease Agreement.
