APPROVING COMPLETION AND ACCEPTANCE OF THE STORM SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT BIRDLAND VISTA, BETWEEN MCANINCH CORPORATION AND BIRDLAND VISTA LLC

WHEREAS, on October 9, 2017 under Roll Call No. 17-1721, the City Council approved a private construction contract in the amount of \$175,253.00, between McAninch Corporation, Douglas D. McAninch, President/CEO, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and Birdland Vista, LLC, Lance Henning, Executive Director and President, 2200 E. Euclid Avenue, Des Moines, IA, 50317 - as Owner, for construction of Storm Sewer Improvements described as storm sewer improvements to serve Birdland Vista in the Birdland Park neighborhood, as shown on Plan File Nos. 564-129/142, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$175,253.00, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and Birdland Vista, LLC, which were approved under Roll Call No. 17-1721, dated October 9, 2017, be received and filed; and that completion of said Storm Sewer Improvements described as storm sewer improvements to serve Birdland Vista in the Birdland Park neighborhood, as shown on Plan File Nos. 564-129/142, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
