WHEREAS, on August 28, 2017 under Roll Call No. 17-1453, the City Council approved a private construction contract in the amount of \$215,088.25, between Team Excavating, Inc., Timothy A. Prohaska, President, 2525 N.E. 80th Street, Altoona, IA, 50009 - as Contractor, and HDR Land Development, LLC, Larry J. Handley, Manager, 2575 North Ankeny Boulevard, Suite 211, Ankeny, IA, 50023 - as Owner, for construction of Sanitary Sewer Improvements described as sanitary sewer improvements located in The Woods of Copper Creek Plat 4, located east of E. 48th Street north of Easton Boulevard, constructed in accordance with the contract documents and as shown on Plan File Nos. 587-137/164, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
