APPROVING COMPLETION AND ACCEPTANCE OF THE
PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, KRAUSE GATEWAY CENTER,
BETWEEN CORELL CONTRACTOR, INC. AND LINDEN STREET INVESTMENTS LLC

WHEREAS, on February 19, 2018 under Roll Call No. 18-0254, the City Council approved a private construction contract in the amount of \$63,757.00, between Corell Contractor, Inc., Grant S. Corell, President, 1300 Lincoln Street, West Des Moines, IA, 50265 - as Contractor, and Linden Street Investments LLC, Kyle J. Krause, CEO, 6400 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Paving Improvements described as paving and associated modifications on Grand Avenue from 14th Street to 15th Street, 14th Street from Grand Avenue to Ingersoll Avenue, and Ingersoll Avenue from 14th Street to 15th Street, for Krause Gateway Center, as shown on Plan File Nos. 564-040/043, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$63,757.00, which have been constructed in substantial compliance with the contract documents between Corell Contractor, Inc. and Linden Street Investments LLC, which were approved under Roll Call No. 18-0254, dated February 19, 2018, be received and filed; and that completion of said Paving Improvements described as paving and associated modifications on Grand Avenue from 14th Street to 15th Street, 14th Street from Grand Avenue to Ingersoll Avenue, and Ingersoll Avenue from 14th Street to 15th Street, for Krause Gateway Center, as shown on Plan File Nos. 564-040/043, is hereby acknowledged and that said Paving Improvements are hereby accepted.
