WHEREAS, the Street Maintenance Division of the Public Works Department, along with the City of West Des Moines, Polk County and 25 other public entities representing the Central Iowa Salt Group (CISG) wished to solicit joint bids for rock salt for delivery to the Metropolitan Salt Storage Facility, and to individual CISG agencies storage facilities; and

WHEREAS, the City of West Des Moines through its Public Works Department, on behalf of CISG, solicited invitation for bids by advertisement and mailing to seven (7) potential bidders with four (4) bids received; and

WHEREAS, the low dollar compliant bid for delivery to the metropolitan storage facility was received from Hutchinson Salt Co., 136 W. 12<sup>th</sup> Street, Baxter Springs, KS 66713, Larry Bingham, President, at a unit cost of \$69.03/ton, or \$828,360.00 for 12,000 tons; and

WHEREAS, the low dollar compliant bid for delivery to the City of Des Moines Public Works Supply Yard was received from Central Salt L.L.C., 1420 State Hwy 14, Lyons, KS 67554, Thomas Peterson, President, at a unit cost of \$63.66/ton, or \$159,150.00 for 2500 tons; and

WHEREAS, Municipal Code section 2-726(m) authorizes the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, funding is available from PW240402/Street Maintenance for a total cost of \$987,510.00; and

WHEREAS, the Procurement Administrator and the Public Works Department recommend approval of the low dollar compliant bid;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the low dollar compliant bid from Hutchinson Salt Co. for 12,000 tons rock salt delivered to the metropolitan storage facility at a total cost of \$828,360.00, and the low dollar compliant bid from Central Salt L.L.C. for 2500 tons delivered to the Des Moines Public Works Supply Yard at a total cost of \$159,150.00 for a combined total of \$987,510.00.
