RESOLUTION HOLDING HEARING ON HONORARY NAMING OF ROLLINS STREET BETWEEN 41ST STREET AND 42ND STREET AS JOHN VIARS STREET

WHEREAS, on May 4, 2009, by Roll Call No. 09-801, the City Council adopted a policy for the naming and renaming of City streets, facilities and park land in the City of Des Moines, which policy provides, in part, that the Mayor, Council Member, or Council as a whole may sponsor a request for naming or renaming on the Council agenda and that Council action to approve a name change may be expedited if deemed appropriate by Council; and

WHEREAS, on June 3, 2019, by Roll Call No. <u>19-0882</u>, the City Council received a communication from the City Plan and Zoning Commission advising that at a public hearing held on May 16, 2019, its members voted 9-0 to recommend **APPROVAL** of a City-initiated request to provide an honorary name of "John Viars Street" to the 4100 block segment of Rollins Street between 41st Street and 42nd Street for the retiring director of the Des Moines Playhouse, with addressing and wayfinding retaining the name of Rollins Street; and

WHEREAS, the above-referenced naming policy provides that public notice will be given and a public hearing held on any naming or renaming proposal; and


WHEREAS, on June 3, 2019, by Roll Call No. 19-0882, it was duly resolved by the City Council that the proposal to provide an honorary name to the 4100 block segment of Rollins Street be set down for hearing on June 24, 2019 at 5:00 p.m. in the Council Chambers at City Hall; and

WHEREAS, due notice of said hearing was published in the Des Moines Register, as provided by law, setting forth the time and place for hearing on said proposed street renaming; and

WHEREAS, in accordance with said notice, those interested in said proposed honorary street naming, both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts, and any and all statements of interested persons and arguments of counsel, any objections to the proposed honorary naming of "John Viars Street" to the 4100 block segment of Rollins Street between 41st Street and 42nd Street, are hereby overruled, and the hearing is closed.
- 2. The honorary naming of the 4100 block segment of Rollins Street between 41st Street and 42nd Street is hereby approved.
- 3. The cost for materials and labor for purchase and installation of the honorary name signage shall be invoiced by the City to the Des Moines Community Playhouse as initial requestor.
