ACCEPTANCE OF REAL ESTATE DOCUMENTS FROM WAKONDA CLUB FOR ACQUISITION OF PROPERTY LOCATED AT 3915 FLEUR DRIVE FOR THE FLEUR DRIVE RECONSTRUCTION – GEORGE FLAGG PARKWAY TO WATROUS AVENUE PROJECT

WHEREAS, Wakonda Club owns property located at 3915 Fleur Drive, and has offered to sell property interests ("Property") for right-of-way needed for the Fleur Drive Reconstruction – George Flagg Parkway to Watrous Avenue Project ("Project") to the City of Des Moines; and

WHEREAS, City of Des Moines ("City") staff has negotiated a purchase price of \$225,000.00 with Wakonda Club for acquisition of the necessary right-of-way along Fleur Drive, north of the club's main entrance, for construction of roadway improvements and a public sidewalk, which price is equal to the estimated fair market value of the Property and damages caused by the Project.



That the Finance Director is authorized and directed to issue checks to pay any costs certified by the Legal Department and the Engineering Department, and the Real Estate Division Manager is authorized and directed to obtain the checks, if any, needed to carry out this transaction and to deliver them to the payee(s).

That the Real Estate Division of the Engineering Department is directed to obtain the Legal Department's review and approval of all closing documents prior to closing.

That the City Clerk is hereby authorized and directed to endorse upon the Warranty Deed and Temporary Easement for Construction and Construction-Related Activities the approval and acceptance of this Council; the Mayor is authorized and directed to sign the Offer to Purchase Real Estate and Acceptance and all necessary real estate documents associated with this acquisition; and the City Clerk is further authorized and directed to deliver the aforementioned documents to the Real Estate Division Manager, who shall proceed to closing in accordance with standard real estate practices.
