APPROVAL OF GRANT AGREEMENTS WITH THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR FUNDING THE CITY'S FIFTH YEAR (2019) ACTION PLAN OF THE 2015-2019 HUD CONSOLIDATED PLAN

WHEREAS, on November 5, 2018, by Roll Call No. 18-1867, the City Council authorized and directed the City Manager to submit the 2019 Consolidated Plan to the HUD; and

WHEREAS, the 2019 Consolidated Plan is a community-wide development strategy designed to meet the needs of low- and moderate-income persons residing in the City of Des Moines, and includes a five-year strategy and one-year action plan for 2019 Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), and Emergency Solutions Grant (ESG) funds, SF 424 application forms and required certifications, and a Citizen Participation Plan which complies with HUD regulations; and

WHEREAS, HUD has now forwarded three Grant Agreements and Funding Approvals for \$3,657,970 (CDBG), \$958,732 (HOME), and \$313,288 (ESG), as on file with the City Clerk and by this reference made a part hereof, which represent grant awards for use in the City's 2019 CDBG, HOME, and ESG programs, and which require approval and execution by the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above referenced Grant Agreements by and between HUD and the City of Des Moines, whereby the City will receive grant awards of \$3,657,970 (CDBG), \$958,732 (HOME), and \$313,288 (ESG) funding for the implementation of the Fifth Year (2019) Annual Action Plan of the 2015-1019 Consolidated Plan for the period of January 1, 2019 to December 31, 2019, are hereby approved.

BE FT FURTHER RESOLVED that the Mayor is hereby authorized and directed to execute the above referenced Grant Agreements and the City Clerk to attest to his signature.
