APPROVING AND AUTHORIZING EXECUTION OF AN AGREEMENT WITH POLK SOIL AND WATER CONSERVATION DISTRICT TO PROVIDE FUNDING FOR AN OXBOW RESTORATION PROJECT IN THE FOURMILE CREEK WATERSHED

WHEREAS, by Resolution No. 12-1381, on August 27, 2012, the City Council approved a 28E Agreement whereby the City joined with other entities to create the Fourmile Creek Watershed Management Authority which resulted in development of a watershed management plan in 2015; and

WHEREAS, Polk Soil and Water Conservation District (PSWCD) is the watershed coordinator and has identified an opportunity on private property to restore an oxbow along the main channel of Fourmile Creek north of Ankeny, which would result in water quantity reduction benefits by reconnecting the flood plain areas and water quality benefits by restoring natural vegetation and habitat; and

WHEREAS, Public Works Department staff have negotiated an agreement with PSWCD providing that the City will provide up to one half of the estimated costs of such project, \$34,5000, and PSWCD will be responsible for ensuring that the project construction and maintenance meets the Natural Resource Conservation Service Standards, a copy of which is on file with the City Clerk's Office; and

WHEREAS, the Public Works Department has determined that the said project on private property within Polk County is a Best Management Practice which will directly benefit the stormwater management utility and its operations and purpose, pursuant to Des Moines Municipal Code Section 118-272(b); and

WHEREAS, the Public Works Department recommends approval of this Agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Agreement for Funding, Construction, and Management of Watershed Improvements in Fourmile Creek Watershed, a copy of which is on file in the City Clerk's Office, is hereby approved, and the Public Works Director is hereby authorized and directed to sign such Agreement on behalf of the City and the City Clerk to attest to the Director's signature.
