WHEREAS, the Department of Public Works Department, along with the Cities of West Des Moines, Waukee, Johnston, Windsor Heights and Dallas County solicited joint bids for the supply and delivery of deicing chemicals for the 2019-2020 snow and ice control season.

WHEREAS, the City of West Des Moines mailed bid packages to eighteen potential bidders with seven (7) bids being received; and

WHEREAS, the low dollar compliant bids were received from Smith Fertilizer and Grain Co Inc, 1650 Quebec Street, Knoxville, IA 50138, for the supply and delivery of a full tank of Geomelt at a unit cost of \$0.80 per gallon and for the supply and delivery of a full tank of Calcium Chloride at \$1.38 per gallon; and

WHEREAS, Municipal Code section 2-726(m) authorizes the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, funding is available from PW240402, S360 Street Maintenance for a total annual estimated cost of \$136,600; and

WHEREAS, the Procurement Administrator and the Public Works Department recommend approval of the low dollar compliant bids;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the low dollar compliant bids from Smith Fertilizer and Grain Co Inc for the supply and delivery of up to 50,000 gallons of Calcium Chloride and up to 70,000 gallons of Geomelt for a total annual estimated cost of \$136,600.
