WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for the purchase of thirteen (13) vehicles that met the criteria for replacement and were approved by the Fleet Oversight Committee (FOC); and

WHEREAS, the thirteen (13) vehicles are being procured through the competitive bid process issued by the Iowa Department of Administrative Services (DAS); and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, ten (10) vehicles, including eight (8) 1/2-ton extended cab 4 x 4 pickup trucks and two (2) compact extended cargo vans are being purchased from Stew Hansen Dodge City, 12103 Hickman Road, Des Moines, IA 50323, (Dan Boettcher, General Manager), in the amount of \$235,855.00 using DAS Purchasing Contract MA 005 19098 STP Group 4; and

WHEREAS, three (3) 3/4-ton crew cab 4 x 4 pickup trucks are being purchased from Dewey Ford, 3055 SW Delaware, Ankeny, Iowa 50021, (Dan Boettcher, General Manager), in the amount of \$95,417.00 using DAS Purchasing Contract MA 005 19097 HPU Group 10; and

WHEREAS, funding is available from I201, Operating Budget, Equipment Replacement for a total amount of \$331,272.00; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of thirteen (13) replacement vehicles, ten (10) vehicles from Stew Hansen Dodge City and three (3) vehicles from Dewey Ford in the total amount of \$331,272.00 using the Iowa Department of Administrative Service (DAS) Contracts MA 005 19098 and MA 005 19097.
