BE IT FURTHER RESOLVED: That \$160,017.20 is the total cost, of which \$145,039.44 has been paid the Contractor, and \$10,177.24 is now due and is hereby approved as final partial payment for the above project, the remaining balance of \$4,800.52 is to be paid at the end of thirty days, with funds retained for unresolved claims on file in accordance with Iowa Code Chapter 573.

BE IT FURTHER RESOLVED: That the Des Moines Finance Director be and is hereby authorized to release said retainage if suit is not filed as above provided.
